- Before Applying:
 - o Must be an existing Standard Commissioned Notary Public
 - o Contract with an appropriate third-party service provider
 - Review applicable statutes and rules
- Complete
 - Application Registration for Online Notary Public form
 - Online Notary Public: Required Information form
 - State of Florida Bond of Notary Public or Online Notary Public (\$25,000)
 - 2-Hour Remote Online Notary Education Training Course and receive a Certificate of Completion
- Have at least a \$25,000 Errors and Omissions Policy or Select appropriate Errors and Omissions Policy below
- The Online Notary Public Commission will expire when the Standard Notary Public Commission expires

What Happens Next?

- American Surety Company will file the required documents with the State of Florida.
- Once the notary commission has been approved, the Remote Online Notary Service Provider chosen by you will receive the approval from the State. The Remote Online Notary Service Provider will communicate to you of the notary commission approval.
- Once the notary commission has been approved, we will mail the Errors and Omissions Policy, if additional coverage was desired, to you.
- **NOTE:** It can take 6-8 weeks from the point the online notary application and bond are filed with the State of Florida for the online commission to be approved.
- If the online notary commission is not approved, the Remote Online Notary Service Provider will communicate with you the reason(s) the online notary application was declined.
